September – October 2012	Appellant and Deceased commenced a relationship.	
Beginning of 2013	Appellant and Deceased moved into a unit together.	
Thursday, 7 March 2013	Appellant showed Mr Lalot a cut down shotgun.	
Friday, 8 March 2013	Deceased told Ms Sekona that she and the Appellant had a fight and their relationship was over.	
Friday, 8 March 2013	Ms Elphick spent Friday night with the Appellant at a motel.	
Saturday, 9 March 2013 During the day	Deceased told a work colleague, Ms Fernan that there was a fight on Friday.	
Saturday, 9 March 2013 Around 8pm	Deceased told Ms Sekona that she was having a friend put new locks on the unit. Deceased asked Ms Sekona's father if she could stay with him.

	message from the deceased that she would not be in at work on Monday.	
Sunday 10 March 2013 around 4pm	Deceased told Ms Pollitt that she planned to leave the Appellant.	
Sunday 10 March 2013 In the evening	Appellant, Mr Writer and Ms Pollitt went to the Springwood Hotel. Mutually abusive text messages were sent between the Appellant and deceased.	
Sunday 10 March 2013 In the evening	Appellant returned to the unit ahead of Mr Writer and Ms Pollitt.	
Sunday 10 March 2013 In the evening	The deceased sent Mr Fenton a text message asking him to pick her up. Mr Fenton rang the Appellant to discuss a drug purchase and arrived 20 minutes later.	
Sunday 10 March 2013 between 8pm and 8:30pm	Mr Fenton arrived and he and Mr Writer entered the unit. Mr Fenton and Mr Writer saw the Appellant with a shotgun. He moved out of their sight and they heard the gun discharge, injuring the Deceased.	
Sunday 10 March 2013 at 9:08pm	The Deceased was taken to hospital and showed no signs of life.	
Monday 11 March 2013	Appellant was charged and in police custody	
6 February 2015	Indictment presented	
28 October 2015	Trial commenced	
Wednesday 4 November 2015	Verdict returned	
Thursday, 19 November 2015	Sentence
