

| | June 2001 | Pursuant to a lease, the appellant lived at premises known as 12 Jade Street, Maddington in the state of Western Australia ("the Property") [AB 148.27-28; 238.60]. |
| | 19 August 2001 | Anthony David Tapley ("Tapley"), attended the Property and was subsequently shot and killed by the appellant on the roadside verge outside the Property [AB 238-242]. |
| | 17 April 2002 | The Respondent filed a Notice of Motion seeking a declaration that property of the appellant is available for confiscation instead of crime-used property under section 22(1) of the <i>Criminal Property Confiscation Act 2000</i> (WA) [AB 2-3]. |
| 30 | 14 May 2003 | The Appellant was convicted of the wilful murder of Anthony David Tapley at Maddington on 19 August 2001 [AB 238.53-58]. |
| | 16 June 2003 | Scott J sentenced the appellant to life imprisonment in strict security with a non-parole period of 22 years [AB 241-242]. |
| | 26 April 2004 | The appellant filed a Notice of Objection pursuant to section 79 of the Act [AB 5]. |


- 29 January 2009 Jenkins J heard the respondent's Notice of Motion and the appellant objection [AB 245-276].
- 19 March 2009 Jenkins J handed down her reasons for judgment refusing to make the declaration sought by the respondent [AB 246-279].
- 24 March 2009 The respondent appealed the decision of Jenkins J to the Court of Appeal of the Supreme Court of Western Australia [AB 281-283].
- 28 April 2009 The respondent filed its grounds of appeal from the order of the Honourable Justice Jenkins dated 19 March 2009 [AB 282-283].
- 10 16 November 2009 The Court of Appeal of the Supreme Court of Western Australia heard the respondent's appeal from the order of Jenkins J dated 19 March 2009 [AB 285-307].
- 12 March 2010 The Court of Appeal of the Supreme Court of Western Australia allowed the appeal and set aside the orders of Jenkins J [AB 285-307].
- 27 October 2010 The High Court of Australia granted special leave to the appellant to appeal the order of the Court of Appeal of the Supreme Court of Western Australia dated 12 March 2010 [AB 308-309].
- 20 9 November 2010 The appellant filed its Notice of Appeal pursuant to special leave granted on 21 October 2010 from the whole of the judgment of the Court of Appeal of the Supreme Court of Western Australia given on 12 March 2010 [AB 310-313].
