1989-1998	Period of alleged criminal conduct during which the first respondent worked for <i>Bank Surya</i> in Indonesia in a senior position, including for at least 5 years as the President Director	
00.04.98	<i>Bank Surya</i> was declared by the Indonesian Government as a "suspended bank" and ordered to stop its business operations on 4 August 1998	
04.04.98	Commencement of Indonesian media reports in relation to the collapse of <i>Bank Surya</i>	
25.07.99	First respondent first arrived in Australia	
16.08.99	Certificate of Good Conduct issued by Indonesian Police to the first respondent



22.11.99	The first respondent registered his Perth address with the Indonesian Consulate in Perth	
00.03.00	The first respondent travelled to Indonesia	
18.10.00	First summons issued to the first respondent by the Indonesian Prosecutor during the investigation stage	
07.02.01	Further summons issued to the first respondent by the Indonesian Prosecutor	
07.02.01 - 13.11.02	Further summonses issued to the first respondent's last known place of residence as well as the placement of notices in media and on court buildings	
08.08.01	Further summons issued to the first respondent by the Indonesian Prosecutor	
04.04.02	Notices of the summons to the first respondent placed in the <i>TERBIT Daily</i> and <i>Bisnis Indonesia</i>	
16.05.02	The Central Jakarta District Court (District Court) ordered the Public Prosecutor to again summons the first respondent to appear in court on 21 May 2002	
21.05.02	The District Court ordered the first respondent to be re-summonsed	
28.05.02	Letter from Village Head notifying that the first respondent could not be contacted	
30.05.02	The District Court ordered the first respondent to be re-summonsed and for advertisements to be published in 4 newspapers	
25.06.02	Chief Judge ordered the Prosecutor to re-summons the first respondent to appear on 8 July 2002. Summons placed in <i>Kompas</i> , <i>Media Indonesia</i> , <i>Republika</i> and the <i>Jakarta Post</i>	
08.07.02	Prosecutor asked the Judge to proceed with the first respondent's trial and reading of the indictments. Judge decided trial would proceed on 24 July 2002.	
15.07.02	Central Jakarta Prosecutor's Office issued further summons to the first respondent to appear on 24 July 2002	
24.07.02	Commencement of trial of first respondent <i>in absentia</i>	
11.11.02	First respondent granted Australian citizenship	
13.11.02	First respondent convicted <i>in absentia</i> by the District Court for the offence of corruption contrary to Article 1 paragraph (1.a) Indonesian Law No. 3 Year 1971 on Combating Corruption Crime, and sentenced to life imprisonment with a fine

14.11.02	The first respondent changed his name in Western Australia to "Adrian Adams"	
28.11.02	Decision of the District Court published in the <i>Republika</i> newspaper and an announcement of the court decision also placed on the information board in all Government offices of the Central Jakarta District	
02.06.03	Dismissal of High Court appeal initiated by the first respondent's co-accused, Mr Sutrisno, and heard in the first respondent's absence	
01.07.03	Decision of High Court notified through an announcement in the District Court and the <i>Suara Pembaruan Daily</i> newspaper	
03.07.03	Head of the Central Jakarta District Prosecution Office issued a "Memo of Decision Execution Order" and the first respondent was declared by Indonesia to be a "fugitive"	
16.12.04	The first respondent changed his name to "Adrian Adamas"	
20.12.04	Central Jakarta District Prosecution Office sent a letter to Interpol requesting assistance to locate and arrest the first respondent	
17.01.05	Interpol Red Notice published	
Date not known	"Shortly after" Red Notice issued, Australian authorities became aware that a person matching the first respondent's description was located in Australia	
26.11.08	Indonesian warrant issued for the arrest of the first respondent	
28.11.08	Indonesia made a formal extradition request to Australia for the surrender of first respondent	
28.11.08	Warrant issued by Magistrate Boon and the first respondent provisionally arrested in Perth	
18.09.09	Magistrate Paul Heaney determined that the first respondent was eligible for surrender to Indonesia and issued a warrant under s 19(9) of the <i>Extradition Act 1988</i> (Cth) (the Act), committing the first respondent to prison to await surrender or release pursuant to an order under s 22(5) of the Act.	
03.12.10	Submission prepared by officers of the Attorney-General's Department for consideration by the appellant in determining whether the first respondent should be surrendered to Indonesia	
17.12.10	The appellant determined, under s 22(2) of the Act, that the first respondent be surrendered to Indonesia	




