1.	1950s	Hancock Prospecting Pty Ltd ( <b>Hancock Prospecting</b> ) and Wright Prospecting Pty Ltd ( <b>Wright Prospecting</b> ) form a partnership and explore for iron ore in Western Australia under the name Hanwright Iron Mines ( <b>Hanwright</b> ).	
2.	12/12/1962	Agreement executed between E.A Wright, L.G. Hancock, Wright Prospecting, Hancock Prospecting, Hamersley Iron Pty Limited ( <b>Hamersley Iron</b> ) and Rio Tinto Management Services (Australia) Pty Limited ( <b>1962 Agreement</b> ).	
3.	11/08/1967	Agreement executed between the State and Hancock Prospecting and Wright Prospecting ( <b>1967 Hanwright State Agreement</b> ) pursuant to which the State is to grant Hanwright rights of occupancy over certain temporary reserves.	
4.	23/10/1967	Iron Ore (Hanwright) Agreement No 19 of 1967 is assented to. The Act approves the 1967 Hanwright State Agreement.	
5.	31/01/1968	Agreement executed between Wright Prospecting, Hancock Prospecting and Hamersley Iron ( <b>1968 Agreement</b> ).	
6.	21/03/1968	The State grants rights of occupancy over TRs 4594H-4627H to Wright Prospecting and Hancock Prospecting until 31 December 1968 for the purposes of the 1967 Hanwright State Agreement.	
7.	8/10/1968	Agreement executed between the State, Hancock Prospecting, Wright Prospecting and Mount Bruce Mining Pty Limited ( <b>1968 Hanwright State Amendment Agreement</b> ). It amends the 1967 Hanwright State Agreement.	
8.	12/11/1968	Iron Ore (Hanwright) Agreement Act No 49 of 1968 is assented to. The Act approves the 1968 Hanwright State Amendment Agreement.	

No	Date	Event	Appeal Book
9.	10/10/1969	The State cancels TRs 4594H-4627H and grants to Wright Prospecting and Hancock Prospecting rights of occupancy over TRs 4937H-4967H, pursuant to the 1967 Hanwright State Agreement (as amended by the 1968 Hanwright State Amendment Agreement).	
10.	5/05/1970	Agreement executed between Wright Prospecting, Hancock Prospecting, Hamersley Iron and Mount Bruce Mining in respect of TRs 4937H-4967H ( <b>1970 Agreement</b> ).
