



Date	Event	Appeal Book Reference
██████████ 1993	The appellant's date of birth.	
██████████ 1997	The complainant's date of birth.	
11 October 2004 – 30 June 2005	Date range for counts 2 and 3 (committed a few weeks apart). The appellant was between 11 years and 7 months and 12 years and 4 months old. The complainant was between 6 years 9 months and 7 years 6 months old.	
26 May 2005 – 19 June 2007	Date range for count 4. The appellant was between 12 years and 3 months and 14 years and 4 months of age. The complainant was between 7 years 5 months and 9 years 6 months old.	
20 October 2010	A Job Capacity Assessment Report on the appellant was completed. The appellant was 17 years old.	
1 February 2012	Peter G Champion, Clinical Psychologist, completed a psychological assessment of the appellant. The appellant was 18 years old.	

4 September 2013 (complainant: 15 years old)	The complainant was interviewed by police 8 years after the conduct in respect of counts 2-3. The complainant was then 15 years old.	
27 August 2014	The appellant was tried by Judge Letherbarrow SC on counts 1-4. Judge Letherbarrow SC directed acquittal on count 1. The appellant was 21 years old.	
28 August 2014	The appellant was convicted by Judge Letherbarrow SC of counts 2, 3 and 4.	
27 November 2014	Sentence proceedings before Judge Letherbarrow SC.	
5 December 2014	The appellant was sentenced to 2 years and 5 months imprisonment with a non-parole period of 11 months, commencing on 5 December 2014.	
17 March 2015	The appellant filed the Notice of Appeal against conviction and sentence.	
15 June 2015	Hearing in the NSW Court of Criminal Appeal.	
26 August 2015	Decision of the NSW Court of Criminal Appeal handed down.	
14 May 2016	The appellant applied for special leave to appeal from the judgment of the Court of Criminal Appeal.	
21 July 2016	Special leave to appeal against the judgment of the Court of Criminal Appeal was granted by Gageler and Gordon JJ.	
4 November 2015	The appellant's non-parole period expires.	
4 May 2017	The appellant's sentence expires.
